Clear Mobile €12.99 Price Plan

Effective from 28 March 2025, this plan will be available to new customers.

These terms govern your use of your Clear Mobile €12.99 price plan (your "Plan") and they apply in addition to and form part of the **Clear Mobile General Terms** and any additional service conditions you have signed up to (together; the "Terms"). If there is any conflict between the Terms then the order of precedence is: these Plan terms, followed by the Clear Mobile General Terms. All prices include VAT unless otherwise stated.

- 1. Your Plan: Your Plan costs €12.99 for 30 days and includes:
 - 1.1. Unlimited data in Ireland with no fair usage allowance;
 - 1.2. Unlimited calls to any network in Ireland;
 - 1.3. 10,000 Anytime texts to any network in Ireland; and,
 - 1.4. Unlimited calls, 10,000 Anytime texts and 19GB data while roaming in the EEA.

Unused allowances within the Plan do not carry over from month to month. For any use outside of the above; you will be charged out of plan charges set out below.

- **2. Duration:** Your Plan is for a 30 day minimum term which you cancel at any time by contacting us with 30 days notice.
- 3. Your Mobile Speed: The estimated maximum attainable 5G download internet speed is 25Mbps and upload internet speed is 5Mbps and the estimated maximum attainable 4G download internet speed is 10Mbps and upload internet speed is 3Mbps. You are not guaranteed to experience this maximum speed; the actual speed you experience will depend on a number of factors, including location, network coverage, network signal and technical or operational issues.
- 4. Using this Plan: You must use our Services for private, personal, and legitimate consumer purposes only. If we are of the opinion that your usage is contrary to these principles; for example if your usage is excessive to the extent that it is negatively impacting the our Network, or if your usage constitutes commercial or fraudulent use or is in breach of the law; we reserve the right to suspend, at our absolute discretion, modify or restrict use of the service or to disconnect you from our Network. We will make reasonable efforts to contact you before suspending or terminating the Services but we are not liable for any loss you may suffer through any suspension covered by this condition.

5. Unlimited Calls

- 5.1. Your "Unlimited Calls" allowance applies to the following minutes when in Ireland or roaming in the EEA for:
 - a) Calls to Clear Mobile numbers (On-net and On-net Home);
 - b) Calls to other Irish mobile network or Irish fixed line numbers (Cross-net and Cross-net Home);
 - c) Calls to 1850, 1890, 0818, or 076 non-geographical numbers; and,
 - d) Calls to your Voicemail.
- 5.2. Inclusive calls will apply when roaming in the EEA for calls to Ireland and EEA mobile numbers and landlines.
- 5.3. Your allowance is subject to a fair use threshold of 45,000 minutes per billing period. Any usage over the threshold will be charged at the out of plan rates set out below.
- 5.4. Your allowance does not include: calls to premium rate numbers, non-geographic numbers (with the exception of calls to Irish 1850, 1890, 0818 and 076 numbers), international calls, calls made while Roaming outside the EEA, calls to other 'special numbers' such as directory enquiries or numbers beginning with 0700 and any other call types.

6. Anytime 10,000 Texts

- 6.1. Your "Anytime 10,000 Texts" allowance applies to the following texts when in Ireland or roaming in the EEA for:
 - a) Texts to Clear Mobile numbers (On-net and On-net Home); and,
 - b) Texts to other Irish mobile network numbers (Cross-net and Cross-net Home).
- 6.2. Inclusive Texts will apply when roaming in the EEA for texts to EEA mobile numbers.
- 6.3. Your allowance is 10,000 texts per billing period. Any usage over the threshold will be charged at the out of plan rates below.
- 6.4. Your allowance does not include: MMS (Multimedia Messaging Services) or texts to Landlines, international texts, texts sent while roaming outside the EEA, premium rate numbers, non-geographic numbers, texts to any other 'special numbers' such as directory enquiries or numbers beginning with 0700 and any other texts.

- 7. Unlimited Data Your "Unlimited Data" allowance will apply when in Ireland and when roaming in the EEA. When roaming in the EEA your data allowance is subject to a fair use allowance of 19GB per billing period in accordance with the EU Roaming Regulations. When you exceed your fair use allowance while roaming in the EEA, a surcharge rate will apply; see Zone 1 (EEA) rate below.
- **8. Out of plan Charges:** If you exceed your Plan allowance or you use services not included in your Plan allowance; these are subject to charges as set out below. Calls and texts are charged per minute or per text (unless otherwise stated). A standard text consists of 160 characters from the standard GSM character set.
