

Clear Mobile General Competition Terms and Conditions

1. These terms and conditions apply to all competitions run by Clear Mobile unless otherwise stated.
2. In order to enter any competition, entrants must correctly undertake the task set or answer the question correctly as the case may be. Competitions are only open to those people identified as being permitted to enter or requested to enter as the case may be.
